An appeal may be submitted with regard to the current directive to the appeal committee (Address: Kiriku 2, 10130 Tallinn, Estonia) pursuant to the procedure stipulated in the Estonian Public Procurement Act within 7 working days as of the day when the participant heard or had to hear of violation of its rights or damage to its interests (Estonian Public Procurement Act § 117 subsection 1 and subsection 2 clause 8-12, § 121 subsection 1).
